ROLE PROFILE

Safeguarding support officers can work within public, private or voluntary sector organisations. With an emphasis on preventative safeguarding, the role partners with different organisations to support in making informed decisions in the safeguarding of children and adults.

TYPICAL JOB ROLES

Safeguarding advisor, safeguarding assistant, safeguarding coordinator in organisations such as education and training providers, health and social care providers, police support staff, fire and rescue services, housing organisations, charities, voluntary sector, religious organisations and professional sports organisations.
